I. CALL TO ORDER

Committee Chairperson Dawn Raymond called the Hawai'i Teacher Standards Board (HTSB) Legislative Committee (Committee) meeting to order at 10:00 a.m.

Committee Chairperson Raymond shared information regarding procedures for virtual committee meetings, then called roll call and established quorum. Ex Officio Committee Member Kristi Miyamae was present in-person. Committee Chairperson Raymond; Committee Members Dale Matsuura and Dr. Katina Soares; and Dr. Cecily Ornelles were present online.
