A. ROLL CALL TO ESTABLISH QUORUM

III. ACTION ITEMS

E. NBI 23-05: Approval of Revisions to Hawaii Revised Statutes for the 2023-2024 Legislative Session

Committee Chairperson Miyamae reviewed NBI 23-05 pertaining to the expansion of criteria for a full Career Technical Education ("CTE") license, which included the Rationale/Background, and asked Licensing Specialist Raymond "RJ" Rodriguez to speak on it.

Licensing Specialist Rodriguez highlighted the difference between this NBI and current criteria as stated in Hawai'i Revised Statutes §302A-803(a)(9).

Committee Vice-Chairperson Raymond asked about a more defined length (e.g., one month) for the comparable experience criterium.

Licensing Specialist Rodriguez stated the CTE Workgroup did not come up with that definition. The Hawai'i Teacher Standards Board ("HTSB") would make that decision.

Committee Chairperson Miyamae mentioned Senator Dela Cruz would be willing to bring this up for discussion if HTSB was unable to include this in the Governor's Legislative Package.

Committee Chairperson Miyamae asked committee members if they had any further questions or discussion. There were no further questions or discussion from committee members.

Committee Chairperson Miyamae called for a roll call vote on whether or not to recommend NBI 23-05, as written, to the full board ("Board") at the General Business Meeting scheduled later at 12:30 p.m.
