# I. CALL TO ORDER

#### A. ROLL CALL TO ESTABLISH QUORUM

Committee Chairperson Justin Mew called the Budget, Personnel, and Strategic Planning Committee Meeting to order at 9:02 a.m.

#### D. HTSB's 2023-2024 Fiscal Review

Committee Chairperson Mew introduced HTSB's 2023-2024 Fiscal Review. He explained since HTSB is a state agency, unspent monies cannot be carried over. He also explained there are cost savings in other areas and planned usage of encumbered funds. He iterated the fiscal year begins on July 1<sup>st</sup> and ends June 30<sup>th</sup>, but HTSB's work continues on, and funds do not actually drop on July 1<sup>st</sup>. He also iterated encumbered funds from the previous fiscal year is very important to keep HTSB's work going.

Committee Chairperson Mew asked committee members if they had any questions or discussion. There were no questions or discussion from committee members.

Committee Chairperson Mew thanked HTSB staff for putting this report together as he knows it is very difficult to work with so many funds.

# **UNAPPROVED**

Executive Director Villalobos offered to speak on the red line items in the personnel section of the report.

Committee Chairperson Mew called on Executive Director Villalobos.

Executive Director Villalobos explained when staff gets raises through bargaining unit negotiations, it brings HTSB's budget into the red because that was not the funding that was dropped at the time. She also explained HTSB was transitioning between secretaries. She mentioned HIDOE and other state agencies have a full-time budget manager, but HTSB does not. She shared HTSB is asking for a budget manager in this next legislative session due to the federal grants HTSB will try to obtain and has already received. She stated she really appreciates the staff for working on this report and reviewing everything from the entire year to ensure HTSB continues to stay in the positive for the budget.

Committee Chairperson Mew asked committee members if they had any further questions or discussion.

**ACTION** — None. There were no further questions or discussion from committee members.

# E. NBI 23-43 Revised: The Hawai'i Teacher Standards Board Election of Board Officers and Committee Assignments for 2024-2025

Committee Chairperson Mew reviewed NBI 23-43 Revised, which adds new board member Dr. Philip Bossert to three committees. He then called for a motion for NBI 23-43 Revised.

Executive Director Villalobos advised a motion was not needed, only a roll call vote for recommendation to the full board ("Board").

Committee Chairperson Mew called for a roll call vote on whether or not to recommend NBI 23-43 Revised, as written, to the Board at the General Business Meeting scheduled later at 11:00 a.m. Committee Chairperson Mew did not vote. All other committee members present voted to recommend.

ACTION — The Budget, Personnel, and Strategic Planning Committee voted to recommend NBI 23-43 Revised, as written, to the Board, with four of five members present voting aye.
