- [NBI 24-04](#) The Expansion of School Counseling Licensure to Include New Grade Levels
- [NBI 24-01](#) License Affirmation (April 2024-July 2024). Congratulations to the 56 teacher candidates who obtained a Student Teacher Permit.

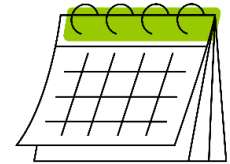


- Ask your teacher candidates to send their Praxis Exam Scores directly to the HTSB using code 8620.
- ETS is offering one free official Praxis score report for individuals who took the Praxis exam between February and July 2024.
- [Title II Data Reporting Window](#) is open until October 30, 2024.
- Teacher candidates in a Special Education Emergency Hire teaching position must be enrolled in an approved Special Education licensure program in accordance with the [Individuals with Disabilities Act Sec 300.156](#).
- Teacher candidates who accept Emergency Hire Teacher positions must complete their clinical experience/student teaching in the licensure field and grade level they will be recommended for upon program completion.
