Office Operations

Activities since the last Board report included:

State partner and stakeholder meetings:

- Met with Senator Michele Kidani to discuss the teacher shortage and how more individuals can be encouraged to enter the profession;
- Gave an initial licensure presentation to teacher candidates at Hawaii Pacific University;
- Met with the Department of Education's Multilingualism Workgroup to discuss licensing for teachers of English Language Learners;
- Attended the Board of Education's regular meeting.

National partner meetings and conference calls:

 Licensing Specialist Erickson and I are attending the Council for Accreditation of Educator Preparation (CAEP) annual fall conference this week, along with representative of several Hawaii EPP. We hope to enhance our knowledge of CAEP processes and learn what is planned for the future of national accreditation. I will be participating in a panel of other state representatives to discuss how Hawaii combines CAEP accreditation in our state approval process; Participated in a conference call to assist in planning of the National Association of State Directors of Teacher Education and Certification (NASDTEC) annual meeting, to be held in June 2017.

HTSB office staff meetings and trainings:

- Convened a full staff meeting to discuss your priority of customer service with Aloha;
- Met periodically with the Licensing Specialists to review data and operational procedures and other staff as needed;
- Met with specialists to review needs of online licensing system and website for the coming year;
- Attended mediation training at the Mediation Center of the Pacific. This training will be helpful in working with our stakeholders and I have recommended it to both specialists as a future customer service training opportunity;
