EPP Consortium Series: Hawaiian Language, History, and Culture October 19, 2023, 9:00 a.m. to 1:00 p.m. Bishop Museum

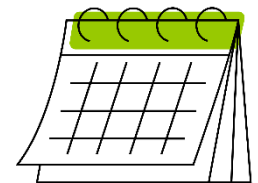
