TITLE: Clarification of Requirements for the Teacher Leader Added Licensure Field

The Hawai'i Teacher Standards Board (HTSB) approves the following criteria for adding the field of Teacher Leader to a Hawai'i license:

Once verified, the following Teacher Leader options may be added to a Hawai'i license **without** further verification at each renewal cycle.

- Completion of a teacher preparation program in Teacher Leadership; OR
- Hold a license/certificate/endorsement from another state with the field of Teacher Leader; OR
- Hold a valid National Board for Professional Teaching Standards (NBPTS) certification in any NBPTS certificate areas; OR
- Complete an in-state HTSB-approved Teacher Leadership program, e.g., Teacher Leader Academy (TLA) Na Kumu Alaka'i, Hawai'i State Fellows, or Teacher Leadership Institute (TLI).

Job-Embedded Teacher Leader Verification for License Renewal

To maintain the Teacher Leader designation on a Hawai'i license, candidates must have their relevant, job-embedded experience verified during each renewal cycle. The school administrator (from the Hawai'i Department of Education, a Hawai'i Public Charter School, or a Hawai'i Private School) must use an HTSB-identified form to confirm four (4) semesters of successful Teacher Leader experience from one of the following areas:

- Curriculum or content specialist/coach
- State office or complex area instructional or data coach
- Served as a Trained Mentor/Cooperating Teacher
- Department/grade level chair

- Service on school-wide, district, state, or national level that develops leadership skills and benefits students, school community, or the profession (e.g., accreditation team membership, school turnaround initiative involvement, or instructional leadership team participation).
 - Service as a union faculty representative alone does not qualify an individual for the Teacher Leader license field.
