Subsequent investigation revealed that LCC's AAQEP accreditation information was inaccurate. The level of licensure for special education should reflect K-6 and 6-12 for initial licensure. HTSB staff followed up by contacting AAQEP to determine the necessary steps to correct the inaccurate accreditation information. AAQEP provided HTSB with a revised action report.




