Justification for Implementing the Program

According to Senate Bill 2359/Act 141¹, "Hawai'i has long suffered from a shortage of qualified public-school teachers" (p. 1). Further, "... the University of Hawai'i System does not offer a sufficient number of classes for students who are pursuing undergraduate degrees in the field of education, especially on the neighbor islands where the shortages are most severe" (p. 3).

Therefore, the Act requires the establishment of ". . . K-12 expanded teaching cohort programs in each county for students who are pursuing undergraduate degrees in education" (p. 3).

Consequently, the School of Education at the University of Hawai'i at Hilo submitted an Authority to Plan a Bachelor of Science in Educational Studies to help meet both the teacher shortage needs and the requirements of Senate Bill 2359/Act 141.

The Authority to Plan a Bachelor of Science in Educational Studies was approved at the university level on December 20, 2022. It is currently working its way through the system-level approval process. We anticipate beginning the Provisional Plan for approval through the University of Hawai'i System Board of Regents in February of 2023. Therefore, we are submitting this Letter of Intent to the Hawai'i Teacher Standards Board now.

Initially, the School of Education plans to provide a licensure track in Elementary Education only. Other licensure tracks, such as Early Childhood Education and Secondary Education, will be added in subsequent academic years.

Employment Outlook for the Bachelor of Science in Educational Studies - Elementary Education Track - Program Completers

The Hawai'i Department of Education² reports that there are 24 Elementary Education (N = 22) and General Education (N = 2) (for which Elementary Education applicants may qualify) positions vacant on Hawai'i Island and 202 positions vacant statewide. Table 1—Elementary Education and General Education Teacher Vacancies by District, shown below, provides vacancy data statewide as of October 1, 2022.
