The Hawai'i Teacher Standards Board approves the following revisions to Hawaii Revised Statute (HRS), to be submitted to the Governor for his consideration as part of the 2024 Governor's Legislative Package and/or support from a legislator.

§302A-803 Powers and duties of the board. (a) In addition to establishing standards for the issuance and renewal of licenses and certificates and any other powers and duties authorized by law, the board's powers shall also include:

(9) Developing criteria for a full career and technical education license, limited to career and technical education teaching assignments, allowing qualified individuals with at least an associate's degree or comparable education and experience, coursework, industry experience, and content expertise to teach;

Rationale/Background:

On April 28, 2023, NBI 22-101 was approved. The 2022-2023 Career Technical Education (CTE) Workgroup reached consensus on modifying the Standard Limited CTE License requirement. "Regarding the CTE Standard Limited License: Allow the requirement of an associate degree to be met by a combination of comparable industry experience and education. Consistent with industry practices and University of Hawaii hiring practices."

All the role groups in the CTE workgroup reached consensus including teacher's union polling that supported the vote. The University of Hawai'i at Mānoa also provided an example of how their hiring procedures allow for associate degree requirements to be met by comparable industry experience and education.
