The HTSB may take action on an EPP's state approval for failure to report changes/modifications of a program or if violations are found at any time during an EPP's accreditation term.

Rationale/Background:

In accordance with Hawaii Administrative Rules (HAR) §8-54-21, §8-54-22, and §8-54-23, an HTSB approved Educator Preparation Provider (EPP) is required to obtain accreditation from a national accrediting body approved by the Board. All continuing reviews, reports, and decisions made by the national accreditor will be submitted to the Board for final consideration and approval.

HTSB staff participated in the AAQEP accreditation meetings and site visit. HTSB staff was not present at the decision-making meeting.



TERM

The accreditation term takes effect immediately and lasts through **December 31, 2030**, or until Chaminade University ceases to be a member in good standing of AAQEP, whichever is earlier. Annual Reports are due at the end of each calendar year, with the first report being due December 31, 2025. In addition, please refer to AAQEP's <u>substantive change policy</u> for guidance on program changes that must be reported.

RATIONALE

The Commission evaluated the program's evidence for each AAQEP standard and determined that all four standards are met. The program prepares candidates to work effectively as professional educators who can adapt to different contexts and continue to grow professionally. The Chaminade University School Counseling Program maintains quality by engaging thoughtfully and critically with evidence of its effectiveness and making revisions to benefit candidates. It engages with stakeholders and partners to strengthen the P-20 education system.
